1. Apologies for absence

2. Declaration of interests

3. Appointments/Membership

4. Trust Status

Annabel Cornish updated Governors with regard to the Gosforth Schools' Trust. John Davison discussed the history of exploring school changes to the 2 new Parent Governors Peter Crabtree and Julia Bayes emphasised positive communication between the 3 tiers. The Governors unanimously agreed to approve the resolution to change category and acquire Trust status and agreed to retain on-going LGP's membership.

Approval of Resolution to Change Category and Acquire Trust Status

The Governors unanimously **approve** the following resolution:

'The Governing Body approves that Archibald First School changes category from a Community School to a Foundation School and acquires Trust Status as part of the 'Gosforth Schools Foundation Trust', in partnership with Broadway East First School, Brunton First School, Dinnington First School, Gosforth Central Middle School, Gosforth East Middle School, Gosforth Park First School, Grange First School, Regent Farm First School, South Gosforth First School.

Newcastle upon Tyne Local Authority (the LA) will also be a partner in the Trust. The change of category is to take effect from 1 April 2014.'

Reasons for the Decision

In making the decision, the Governors believe that the change of category and the acquisition of Trust Status in partnership with the other named schools will:

- Raise standards of attainment for pupils through the sharing of best practice, professional development and curriculum support.
- Support the continuity and progression of services across a continuum of need.

- Provide a forum which could voice the interests of pupils and parents/carers through Health, Social Care and Education in pursuit of equity of access to funding, services, resources, grants and planning.
- Promote the sharing of expertise and skills for the benefit of members and the wider school community.

Approval of agreement to retain on-going LGPS membership

The Governors also **unanimously** approve a resolution to formally request that the LA should maintain on-going membership of the Local Government Pension Scheme (LGPS) for all current non-teaching staff and to allow entry to the scheme for new appointees.
