For children who are <u>3 years-old on or before 31 August 2025</u>

Archibald First School offers 15 free hours of childcare per week which is offered as 2½ days and 30 hours childcare which is offered as 5 days per week in term time. Sight of original birth certificate and proof of address will be required; your application and offer of a place is dependent on this.

Option 1 or Option 2 - 15 hours per week

In applying for and accepting a nursery place at Archibald First School for 15 hours you are entering an agreement to use your initial 15 free hours with Archibald for the entire academic year of 2025-26.

Option 3 - 30 hours per week

<u>For those parents who are eligible for the 30 hours code</u>: In applying for and accepting a nursery place at Archibald First School for 30 hours, you are entering an agreement to use your initial 15 free hours and the additional 15 funded hours with Archibald for the entire academic year of 2025-26. You also agree to confirm your 30 hours code by the deadline requested by Newcastle City Council or this will affect your child's additional free 15-hour place or be charged the cost of the nursery place.

NB: It is your responsibility to reconfirm your 30-hour code every 3 months on the Government portal.

<u>For those parents who are not eligible for the 30 hours code</u>: For those who wish to purchase the additional 15 hours the cost will be approximately £75 per week (to be confirmed at a later date).
